Member of the Public 1 - Tricia Varney

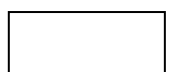
Does anyone have any further feedback regarding the landslide near Hotel Victoria.

Currently the schedule we have is very tight. We are hoping to get the draft plan to be approved at the October Full Council Meeting. This may slip back a month to November if we cannot get it ready in time. After this we can then go through the 6 week consultation process. Presuming there are no issues we can submit to Cornwall Council whilst they look over it for 6 months but whilst they have it does hold weight. I think this should be around December or January by the time it gets sent off.

Cllr J Kenny explained what information each member had in their packs & what the NNP wishes to achieve from implementing the plan.

Firstly she wishes to change the proposal to approving the Polices for the NNP, not approving the Draft Plan as suggested in the Agenda.

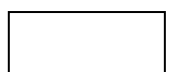
Members discussed at length.

It was proposed by Cllr J Kenny, seconded by Cllr S Carter, and **RESOLVED unanimously to amend the proposal to approve the Polices for the Draft Plan not to approve the Draft Plan as suggested previously.**

It was proposed by Cllr L Gardner, seconded by Cllr A Hannan and **RESOLVED to not include Self Build Properties within the polices that this should be an exception.**

This proposal fell as 4 voted for, 12 against with 2 abstentions.

It was proposed by Cllr J Kenny, seconded by Cllr S Carter and **RESOLVED unanimously to accept the draft policies in principle.**

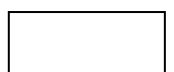
